# The Proceedings

The work flow improved from last year: LIPIcs now uses the OpenConf system that allowed authors to upload their final papers and meta-data directly.

Proceedings are online. DOI and ISBN are provided. Entry in DBLP, etc, will happen shortly.

Proceedings were finished two weeks before the meeting started.
